- b) **Hangar 8 Lease Amendment (Foothill Flight Center)** – Amend Hangar 8 lease agreement to allow subletting storage of non-flight school aircraft for the remainder of the lease.

Discussion: One of the Foothill Flight Center owners is opening a larger flight school at another airport, taking one of the training airplanes, opening up space for one to two additional airplanes that could be hangered. The current lease does not provide for storage of non-flight school aircraft not owned by Foothills. Request is to amend the lease to allow subletting of aircraft not owned by Foothills to be stored in Hangar 8.
