**RESOLUTION DECLARING THE FORMATION OF THE
CAMERON PARK AIRPORT DISTRICT PURSUANT TO
PUBLIC UTILITIES CODE SECTION 22256**

WHEREAS, the Local Agency Formation Commission has approved the formation of the Cameron Park Airport District; and

WHEREAS, the Board of Supervisors of the County of El Dorado, as the conducting authority, submitted the question of formation of the district to the voters; and

WHEREAS, on November 17, 1987, the voters within the boundaries of the proposed Cameron Park Airport District approved the formation of the district,

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of El Dorado County as follows:

1. The Cameron Park Airport District is hereby formed.
2. The boundaries of the district shall be as set forth in the attached boundary description of the Cameron Park Airport District and the map attached hereto as Exhibit "A".
3. The name of the district shall be the Cameron Park Airport District.
4. A certified copy of this resolution shall be filed in the Office of the El Dorado County Recorder and with the Secretary of State of California pursuant to Public Utilities Code Section 22258.
