With the activity at the Lincoln Airport this year, including construction of a new taxiway that will provide space for several more hangars, Lincoln Airport "guru" Jerry Cain felt the time was right to create a formal organization to assist the Montana Aeronautics Division with the upkeep of the facility.



Formation – Public Charity



- Types of nonprofits
 - "Nonprofit" defined in the Internal Revenue Code:
 510(c) corporations don't pay corporate income tax
 - More than 25 types, for examples
 - 501(c)(4) social welfare, e.g. FOCA
 - 501(c)(6) professional association, e.g. NHL
 - 501(c)(3)
 - The only nonprofit where donations are tax deductible



Formation - Benefits



- Benefits of a 501(c)(3)
 - Don't pay corporate income tax on net profits
 - Donations are tax-deductible to the donors
 - Eligible for property tax exemption granted by counties
 - Eligible for nonprofit bulk mail rate
 - Some government contracts and grants are only to nonprofits
 - Some foundations make grants only to nonprofits
 - Nonprofit status communicates dedication to community good
 - Matching corporate donations
 - Nonprofits rates, e.g. credit cards fees

Formation - Restrictions



- Restrictions of a 501(c)(3) in exchange for the benefits
 - Can't distribute profits to shareholders
 - Must have a board to of directors to represent the public's stake in the organization
 - Cannot support or oppose candidates for office
 - Limits lobbying
 - Can't be a guise for personal profits
 - If closed, remaining assets must be distributed to other nonprofits
 - Annual paperwork (state and federal)
