c) <u>Summer Spectacular Parking</u> – The Cameron Park Community Services District (CPCSD) sent CPAD a letter requesting permission to use Baron Court and Boeing Road for parking at no charge to the CPCSD or those attending the event.

MOTION to approve CPCSD request use Baron Court and Boeing Road for Summer Spectacular parking Discussion: Board conditionally approved the request based on the following:

- 1. Cameron Park Services District (CPSD) lists CPAD has "Additional Insured Endorsement" in excess of \$ 1.0 million for cover damages and/or accidents.
- 2. CPSD with contract/coordinate to have additional law enforcement present sufficient for an event of this size.
- 3. CPSD will have a parking team on site to ensure orderly parking and exiting.
- CPSD will provide cleanup/removal of all event related items following the event.

- e) **MOTION** to request that El Dorado County Board of Supervisors direct County staff and stakeholders to evaluate the feasibility of each of the following options:
 - 1. Delete the following language from County Ordinance 10.20.040 (A):

"A. Aircraft shall yield the right-of-way to pedestrians and vehicles."

No other changes to the Ordinance

- 2. In place of that deleted language, consider adding one or more of the following options:
 - A. Aircraft, Pedestrians and Vehicles approaching an intersection shall yield the right of way to Aircraft, Pedestrians and Vehicles already in the intersection, proceeding to enter the intersection only when it is safe to do so.
 - B. Aircraft, Pedestrians and Vehicles travelling in opposite directions upon the same joint use roadway shall each move to the right to permit safe passing.
 - C. Pedestrians and Vehicles must maintain a safe distance from Aircraft at all times.

Each Option should include definitions such as:

- A. Vehicles. Motor vehicles, cars, trucks, trailers, RVs, golf carts, off-road vehicles, motorcycles, mopeds, bicycles, skates, skateboards, personal mobility devices, scooters, and all other forms or modes of transit are included in the term "Vehicles".
- B. "Aircraft" includes all forms or modes designed to be capable of flight.

After discussion, the motion was amended to the following:

- 1. Do not amend any existing ordinances.
- 2. Develop and distribute an annual education plan for the airpark residents. Document distribution and participation.
- 3. Display signage on multiple gates indicating key airpart ordinances.
